Indian Institute of Technology Kharagpur invites applications from Indian Nationals for the following posts on Contract basis with a consolidated remuneration of ₹14000/- per month.

**(1) Post : STAFF NURSE ON CONTRACT**

**Number of Posts :** Three [03] (only female)

**Qualification and Experience :** Intermediate **OR** 10+2 **OR** equivalent and must have passed the examination held by the Nursing Council with three (03) years course in General Nursing and Mid-wifery **OR** BSc. (Nursing).

**Desirable :** Minimum two (02) years relevant experience in a Hospital recognized by the Central or State Nursing Council. Experience in Medical Ward/Surgical Ward/ICU preferable.

**(2) Post : PHYSIOTHERAPIST ON CONTRACT**

**Number of Posts :** Two [02] (one male, one female)

**Qualification and Experience :** Bachelor's Degree in Physiotherapy (BPT) from recognized University/Institute with four (04) years relevant experience **OR** Master's Degree in Physiotherapy (MPT) from recognized University/Institute with two (02) years relevant experience in a reputed centre after completion of the course.

**General Instructions**

1. Reservation for ST / SC / OBC / PWD / Ex-Serviceman as per Government of India Rules.
2. The upper age limit for both the posts is 30 years. However, age relaxation for SC/ST/OBCs/ Ex-Servicemen/Persons with Disabilities (PWD) and women candidates is applicable as per Government of India norms.
3. Initially the appointment will be made for a period of 01 (one) year on contract basis. Extendable based on satisfactory performance.
4. The Institute reserves the right of rejecting any or all the applications without assigning any reasons thereof.
5. Candidates applying for more than one post may apply separately for each post.
6. Candidates should submit their SC/ST/OBCs/Disability Certificate issued by Competent Authority in the prescribed format along with the application form, in support of their claim.
7. Degree as referred above should have been awarded by a recognized University / Institute.
8. Mere eligibility will not vest any right on any candidate for being called for interview. The decision of the Institute in all matters will be final. No correspondence will be entertained from the candidates in connection with the process of selection/interview. Canvassing in any manner would entail disqualification of the candidature.
9. Persons employed in Government / Semi Government Organizations / Autonomous Bodies should submit their application through proper channel. They may, however, send an advance copy of the application. Those who are unable to process their application through proper channel may submit 'No Objection Certificate (NOC) from present employer during the time of interview. However, they should submit an undertaking to that effect. Direct application from such candidates will not be entertained.
10. Incomplete applications or applications without self-attested copies of certificates/testimonials or received after the last date are liable to be rejected.
11. The Institute reserves the right to call only the requisite number of candidates for interview after shortlisting with reference to the candidate's qualification, suitability, experience, etc.
12. The Institute reserves the right to conduct the written / screening test, if the number of applicant is large for a particular post.
13. Candidates who will shortlisted for selection process (Test and/or Interview) will have to produce original documents in support of all the particulars mentioned in their application form regarding their reservation category, educational qualification, experience and other claims during the Interview.
14. No TA/DA will be paid to attend the selection process (Test and/or Interview).
