Indian Institute of Technology Kharagpur invites sealed two part bids from reputed Agencies engaged in transportation of goods for to and fro transportation of goods between Central Stores of IIT Kharagpur and the various Departments/Centres/Schools/Units etc. and loading and unloading in the Central Stores at IIT Kharagpur initially for a period of one year, which may be extended for another one year or more (contract renewable on yearly basis) on satisfactory performance.

Interested and eligible agencies are required to submit their sealed bids 'Technical Bid' with relevant papers in proof of eligibility as per **Annexure – II** and statutory compliances as per **Annexure–III**, the scope of work are given in **Annexure – I**, Terms and conditions are as per **Annexure – IV** and the commercial bid format is as per the **Annexure – V**. Selection will be based on compliance to eligibility and statutory requirements and the price components quoted by the bidder. The commercial bids of only those agencies who would qualify based on Technical Bid documents, will be opened and the lowest bidder will be awarded the contract. **Those who have submitted the tender document against tender no. IIT/S&P/TRANSPORATION/2017-18 dated 11.09.2017, need not submit again. Their bid document will be considered with due course.**

The tender submission fee is Rs. 500/- [Rs. Five Hundred only] (non-refundable) and same must be submitted in the form of Demand Draft drawn in favour of "Indian Institute of Technology Kharagpur" payable at Kharagpur. The EMD is Rs. 5,000/- [Rs. Five Thousand only] (refundable) and same must be submitted in the form of Demand Draft drawn in favour of "Indian Institute of Technology Kharagpur" payable at Kharagpur. Any corrigendum and addendum shall only be published on the Institute Website and CPP Portal.

The two sealed envelopes containing Technical Bid (Envelope – I) & Commercial Bid (Envelope – II) should be placed in a large sealed envelope with reference number **(Tender No. IIT/S&P/TRANSPORATION/2017-18 Dated:10.10. 2017)** to be sent by speed post/courier to "The Deputy Registrar (S & P), Indian Institute of Technology Kharagpur, WB-721302" so as to reach on or before **25th October, 2017 by 4.00 p.m.** The same also could be hand delivered at the same address before the deadline mentioned.

The Technical bid (Envelope –I) will be opened on **25.10.2017 at 4.30 p.m.** in the Office of The Deputy Registrar (S & P), IIT Kharagpur, WB-721302.

SCOPE OF WORK

A : Transportation of Goods with loading and unloading

- To and fro Transportation of Goods between Central Stores of IIT Kharagpur and the various Departments/Centres/ Schools/Units etc. of IIT Kharagpur.
- **Vehicle** : For transportation, vendor must use any one Motorized Vehicle/Battery Operated Vehicle/Leg Pulled Trolley.
- The contract will be on weight and job contract basis in five slabs.
 - (i) Upto 50 kg.
 - (ii) 51 kg. to 150 kg.
 - (iii) 151 kg. to 250 kg.
 - (iv) 251 kg. to 500 kg.
 - (v) 501 kg and above
- The contract will be on job contract basis including lifting the material, safe transportation and delivery at the destination in any point including any floor of a multi-storeyed building in the Institute including the required labour/equipment.
- Adequate safety measures must be taken during loading, transportation and unloading and also at the time of hand over the goods.
- Any damage and destroy of the goods during the scope of the contract will be borne by the contractor only.
- IIT Kharagpur shall not be responsible for any injury, accident, disability, or loss of life to the contractor or to any of its personal that may take place while on duties or otherwise. Any compensation or expenditure towards treatment of such injury, accident or loss of life shall be the sole responsibility of the contractor.

B : Loading and Unloading in the Central Stores, IIT Kharagpur at any time

- Loading and unloading for various industrial gas cylinders in Central Stores as and when required.
- Loading and unloading for medical oxygen gas cylinders in Central Stores as and when required.

PAYMENT TERMS :

The Agency shall submit bills within a week after completion of every calendar month and normally payment will be released within 20 working days from the date of submission of bill if the bill is complete and correct in all respects. The monthly bills submitted by the Contractor shall only be paid as per terms & conditions of Work Order.

ELIGIBILITY CRITERIA

- 1) The tenderer should have minimum one (01) goods vehicles registered as its own name having valid permit (Copies of the vehicle registration certificates & Insurance policies to be attached for the vehicles).
- 2) The tenderer should have minimum two (02) years of experience as on the last date of submission of the tender.
- 3) The agency/firm/company must valid PAN and GST registration number in case of Registered Person or clear declaration including turnover in case of un-registered person.
- 4) The tenderer must have valid labour license.
- 5) **Tender Fee** : The tender submission fee is Rs. 500/- [Rs. Five Hundred only] (non-refundable) and same must be submitted in the form of Demand Draft drawn in favour of "Indian Institute of Technology Kharagpur" payable at Kharagpur.
- 6) **EMD** : The EMD is Rs. 5,000/- [Rs. Five Thousand only] (refundable) and same must be submitted in the form of Demand Draft drawn in favour of "Indian Institute of Technology Kharagpur" payable at Kharagpur. EMD will be returned to the unsuccessful bidders on finalization of the tender process without any interest.

NOTE: Bidders must submit the documentary proof in support of meeting the minimum eligibility criteria. Simply an undertaking by the bidder for any item of the criteria shall not suffice the purpose.

TERMS AND CONDITIONS OF THE TENDER & GENERAL INFORMATION

Please read the following Terms & Conditions carefully before submission of the Tender. Incomplete Tenders will be rejected.

- 1) Indian Institute of Technology Kharagpur invites sealed two part bids from reputed Agencies engaged in transportation of goods for to and fro transportation of goods between Central Stores of IIT Kharagpur and the various Departments/Centres/Schools/Units etc. and loading and unloading in the Central Stores at IIT Kharagpur initially for a period of one year, which may be extended for another one year or more (contract renewable on yearly basis) on satisfactory performance.
- 2) The tenderer shall provide the services continuously as per the award of contract. In case of discontinuation of services by the contractor in the middle of the period or non-satisfactory services, breach of any terms and conditions of the contract, non-compliance of the orders of competent authority etc. the contractor shall be terminated immediately and the tenderer shall also forfeit their performance security deposit.
- 3) IIT Kharagpur reserves the right to terminate the contact at any time without assigning any reasons by giving a one month advance notice to the tenderer.
- 4) The rates quoted in the Financial Bid shall be valid for at least 24 months from the date of award of contract. However, after 24 months the rate may be revised at the own discretion of IIT Kharagpur.
- 5) The tenderer shall get suitable instructions from the Designated Official of IIT Kharagpur and shall provide the services promptly as per requirement. The tenderer should be in a position to supply additional vehicles on short notice as and when required, if any.
- 6) The tender shall be signed by the authorized person and his / her full name and status be indicated below the signature along with official stamp of the tenderer.
- 7) The drivers of the vehicles deployed at IIT Kharagpur site should be fully conversant with the routes of IIT Kharagpur. All drivers must have proper driving licenses.
- 8) In exceptional cases, IIT Kharagpur may call vehicles even after official timing or retain vehicles after official time to cater to sudden work exigencies.
- 9) The drivers of the vehicles deployed on IIT Kharagpur site will obtain the duty slips every day from IIT Kharagpur officials and Drivers shall maintain the log book (timings and weight of the materials) on daily basis and obtain signatures of the users immediately after every duty. IIT Kharagpur officials may demand this log book at any time for inspection. Gate pass will be given and returned to the Officials of IIT Kharagpur after the job is over.

- 10) The drivers also shall be asked to carry files/ papers/letters which is to be handed over to the office/staff at the time of transportation of goods.
- 11) The successful tenderer will have to deposit a performance security deposit of Rs. 20, 000/- (Rupees Twenty Thousand Only) either by Account Payee Cheque [IIT Kharagpur will not pay any interest for this deposit] or in the form of Performance Bank Guarantee (PBG) of any nationalized Bank in favour of Registrar, IIT Kharagpur. This PBG shall cover entire period of contract and shall remain valid for a period of 60 days beyond the period of contract. If contract is further extended beyond the initial period, the PBG shall have to be renewed for the extended period.
