Rs. 183.11 x 26 =Rs. 4760.86= Say Rs. 4761/- per month / per toilet

Note: Quoted rates should be inclusive of all for above mention scope of work such as minimum wages for 22 nos. of manpower's along with the ESI, PF & Other materials as well as other statutory taxes required to carry out the work. Rate quoted per month should be also separated in two parts i.e. Material + labour etc. inclusive of all taxes. However L1 will be decided on the basis of cost of machinery, material another allied item (i.e.A2) other than cost of manpower.
